

Objectives and Investment Policy

- Aims to provide long-term capital growth through global exposure to higher risk assets.
- The fund provides global exposure to a diversified range of assets by primarily investing in funds. The fund typically invests more than 65% in sub-funds of an Irish UCITS fund (Fidelity Common Contractual Fund II) operated by Fidelity which subsequently utilise the experience and specialisms of a number of investment managers (which may include Fidelity) to manage the underlying assets. It may also invest directly in transferable securities (which includes company shares and bonds), money market instruments, cash and deposits.
- Can use derivatives with the aim of risk or cost reduction or to generate additional capital or income in line with the fund's risk profile. May also make extensive use of derivatives including more complex instruments or strategies to achieve the investment objective and these may result in leverage.
- The fund has discretion in its choices of investments within its objectives and policies.
- Asset allocation exposure of the fund will be actively managed and is typically allocated as follows: 100% higher risk assets (e.g. shares) and 0% lower risk assets (e.g. bonds and cash). This may be adjusted to within the ranges: in all market conditions, 80-100% higher risk assets and 0-20% lower risk assets to preserve capital or take advantage of market opportunities.
- Income is accumulated in the share price.
- Shares can usually be bought and sold each business day of the fund.
 With effect from 8 February 2019, this fund will be merged into the Fidelity Multi Asset Open Adventurous Fund.

Risk and Reward Profile

Losses may also be realised if an entity that the fund is exposed to ceases to make interest payments over a period of time or indefinitely. Bond prices have an inverse relationship with interest rates such that when interest rates rise, bonds may fall in value. Rising interest rates may cause the value of your investment to fall.


