Investment Objective 投資目標

The fund aims to achieve capital growth over the long term. The fund invests at least 70% of its assets, in equities of companies from anywhere in the world, including emerging markets. It will seek exposure to long-term market themes that benefit from long-term (structural and not cyclical) economic or social trends, such as disruptive technologies that modify consumer behaviour, demographics (population growth, ageing and middle class growth) and climate change. 基金旨在實現長線資本增長。基金將最少70%的資產投資於世界各地(包括新興市場)公司的股票。基金將尋求投資於長期(結構性而非週期性)經濟或社會趨勢中受益的長期市場主題,例如可改變消費行為、人口結構(人口增長、老齡化及中產階層擴大)和氣候變化的顛覆性技術。


